



## Corporate Contributions/Grant Guidelines

The Hershey Company makes cash grants and contributions to support worthy causes and non-profit organizations that align with our Shared Goodness Promise sustainability strategy. This strategy focuses on four core areas: Shared Futures (supporting children and youth by providing education opportunities, meaningful connections to support social-emotional well-being, and nutrition); Shared Communities (supporting the communities where we operate), Shared Planet (supporting ecosystems and environmental conservation), and Shared Business (complementing business priorities including, but not limited to, diversity and inclusion, responsible sourcing and supply chain efforts).

The following are not eligible for grants:

- Organizations without an Internal Revenue Code 501 (c)(3) non-profit, tax-exempt status
- Individuals
- Organizations outside the immediate areas of The Hershey Company's facilities, with the exception of international, national and state-wide organizations whose programs complement Hershey's strategic priorities. These partnerships are typically by invitation only.
- Political campaigns, political or lobbying organizations, or those supporting the candidacy of a particular individual
- Churches or religious organizations, including seminaries, Bible colleges and theological institutions
- Fraternal organizations
- Labor organizations
- Affiliate organizations of the Cultural Enrichment Fund in Central Pennsylvania
- Film and television show production companies
